

#### MEMORANDUM OF UNDERSTANDING FOR ACADEMIC PARTNERSHIP

This Memorandum of Understanding ("MoU") is entered into between

Each a "Participant" and collectively the "Participants"

Effective as of date 18<sup>th</sup> July 2022

WHEREIN the Participants recognize the mutual benefits of academic collaboration on skill development in the broad area of Augmented and Virtual Reality (AR-VR) and allied technologies.

#### 1. PURPOSE

The purpose of this MoU is to formalize partnerships with emphasis on:

- Academic partnership for offering training Program/Certification Courses for Engineering/Non-engineering Students of the Institute.
- Faculty development program for selected faculties of institute.
- Support for AR-VR laboratory/experience centre development at institute.

#### 2. SCOPE OF COOPERATION

The Participants to collaborate in developing skills in AR-VR technology for students of the Institute in the following ways:

- TechXR shall offer selected courses free of cost to students of the institute to spread awareness of AR-VR technology among students. TechXR will provide specific Access Code using which students can access the courses at the company's learning portal for free.
- The institute shall share the Access Code with its registered students and spread awareness on the available courses.
- The Institute will recommend up to 3 faculty members for faculty development program by TechXR.
- TechXR will provide all the training material, access to learning modules, AR-VR Development Kit, Doubt clearing support, project evaluation and Certificate of course for identified faculty members free-of-cost for participating institute.





### 3. INFORMATION USAGE

The Participants agree not to make improper use of any information that comes to itself or its agents or representatives in the performance of services under this Agreement.

### 4. INTELLECTUAL PROPERTY

- i. The Institute undertakes not to cause or permit anything which may damage or endanger the intellectual property of the Company or the Company's title to it or assist or allow others to do so.
- ii. The Company undertakes not to cause or permit anything which may damage or endanger the intellectual property of the Institute or the Institute title to it or assist or allow others to do so.
- iii. The Company and the Institute undertake not to infringe the intellectual property rights of any third party during the course of this Agreement.

### 5. VALIDITY


The agreement is valid for the period of 3 years from the date of execution. It can be extended further based on mutual agreement between the participants.



**MEMORANDUM OF UNDERSTANDING** between  
Siddhant College of Engineering, Pune and iSchoolConnect Technologies Pvt. Ltd.

THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MOU") is made and entered into by and between Siddhant College of Engineering, Pune and iSchoolConnect Technologies Pvt. Ltd. (hereinafter iSC).

WHEREAS, the parties to this MOU will engage in providing career and future education-oriented guidance to individuals who are students of Siddhant College of Engineering, Pune. iSC will be involved in physical as well as online activities that will aid the leads to seek a suitable future admission to a degree program worldwide or develop the requisite soft skills that shall help them secure a job within the local country.

NOW, THEREFORE, the parties to this MOU mutually agree to the following:

1. Guiding Principles: Siddhant College of Engineering, Pune and iSC alliance will function on the following principles:

- a) Establish a mutually beneficial partnership between Siddhant College of Engineering, Pune and iSC that allows a flexible and creative response to the organizational missions and fiscal needs of both institutions.
- b) Collaboration in planning and implementation of genuine rich media content with the aim to convert leads to either an Essential or a Premium plan. (refer Annexure 1 for pricing plans)

2. Scope of Agreement and Limitations of Authority: The Scope of the Agreement and the parties agree as follows

**A. Governance:**

- (1) The content by iSC will be governed by iSC and subject to rules and policies defined by Siddhant College of Engineering, Pune and iSC together.
- (2) Siddhant College of Engineering, Pune & iSC each will have a representative for joint activities and planning.
- (3) Lead attribution and leads generated for the Essential and Premium plan will be done with complete transparency through the available technical means.
- (4) Lead passing to other organizations/ agencies/ individuals is strictly prohibited. Any such incidence if found will lead to cancellation of contract by either of the parties.

**B. Duties of Siddhant College of Engineering, Pune**: Siddhant College of Engineering, Pune shall have the following duties:

- (1) Provide iSC with means and channels, online and offline, that will help target students of Siddhant College of Engineering, Pune for study abroad.
- (2) Allow iSC to circulate relevant material, limited to careers and higher education with promotional materials about studying abroad and iSC.



(3). Share information with ISC about students interested in availing ISC services. Support ISC wherever needed through the lead generation process.

(4). Assist ISC in conducting informative sessions (online and offline) via webinars and seminars arranged by Siddhant College of Engineering, Pune and provide logistical assistance if necessary. A minimum of 1 webinar/ in-person workshop each quarter will be scheduled. At least one external workshop per year that can be attended by both students, faculty and parents of Siddhant College of Engineering, Pune and other universities in the fraternity.

**C. Duties of ISC:** ISC shall have the following duties:

(1). Collaborate with Siddhant College of Engineering, Pune to assist its students with career guidance and development.

(2). Conduct information sessions (online and offline) as well as one-to-one personalised counselling sessions. A minimum of 1 webinar/ workshop session each quarter.

(3). Develop content for circulation among students of Siddhant College of Engineering, Pune.

(4). Ensure that every member requires assistance through Siddhant College of Engineering, Pune is taken care of and documented in the system and is clearly attributed to Siddhant College of Engineering, Pune.

(5). ISC will provide student support & progression for further international studies (which will support Siddhant College of Engineering, Pune for NAAC points).

(6). Provide product demo to Siddhant College of Engineering, Pune's students and faculty whenever required.

(7). ISC will provide a 50% discount on the packages to the students of Siddhant College of Engineering, Pune till the validity of the contract.

(8). Disburse a unique discount coupon code for ISC's Essential or Premium plan for students in need of either of the plans. The coupon code will be exclusive for the Siddhant College of Engineering, Pune's members with a validity of 1 year. The discount percentage of the coupon code shall be mutually decided post the pilot program.

(9). Become a trusted partner of Siddhant College of Engineering, Pune by helping every student enrolled in the iSchoolConnect Mumbai Community and extending maximum assistance possible.

**D. Instructional Calendar and progress evaluation:**

(1). Siddhant College of Engineering, Pune and ISC will establish an instructional calendar that is consistent with the needs and requirements of both parties.

(2). Both parties will sync up once every quarter to discuss and evaluate progress and layout a roadmap for the next quarter. The parties will also have an annual review meeting.

**E. Media and Public Relations:** Media and public relations regarding the program will be managed according to ISC and Siddhant College of Engineering, Pune's protocols.

**F. Siddhant College of Engineering, Pune's - ISC Pilot:**

(1). Students will be screened and shortlisted by faculty and authorities at Siddhant College of Engineering, Pune and passed on to ISC.

- (2). The pilot will be applicable for Fall 2023 aspirants.
- (3). Free pilot for 5 students of Siddhant College of Engineering, Pune.
- (4). Siddhant College of Engineering, Pune has the right to nominate members for the pilot, but the awardees will be decided by ISC.
- (5). The success of the pilot will be decided upon the number of application submissions along with feedback of students on the product and services provided by ISC.
- (6). The pilot program will be evaluated within 60 days of the pilot initiation.

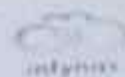



### Recitals
